Growing out of community-based research and in collaboration with Hartland Partnership for Youth and Families, The Glendale Community Learning Center, University Neighborhood Partners, and the High School University Program, we have created a pathway for marginalized high school students to enroll at the University in a *Growing Food Sovereignty* course with pursuant on-campus and community employment.

Air Quality Education for Health and Justice, 2022 (AQEHJ) project is a unique partnership between the University of Utah's Environmental and Sustainability Studies program, two Title I middle schools impacted by poor air quality, and three community learning centers (CLCs). This partnership will ensure that AQEHJ can reach university and middle-school students as well as families, administrators, and policy makers supporting our overarching goal of deepening understanding of the causes and consequences of poor air quality, and advancing local pollution reduction and exposure mitigation policies and practices in underserved areas.
