Designed for quantitative, positivist research, I have been part of the resistance to extension of “Data access and research transparency” (DA-RT) to qualitative and interpretive work. That has included one research article documenting the evolution of DA-RT, appearances on many roundtables, and detailed comments on 8 of the 12 draft Community Transparency Statements produced through the Qualitative Transparency Deliberations.

This NPRM requested comments regarding proposed changes to the regulations for protecting human subjects in research, as set forth in 45CFR46, Subpart A (the “Common Rule”). On January 6, 2016, together with Dvora Yanow and Daniel Levin, I submitted a 10-page comment on the proposed elimination of the exemption for public officials—a proposed revision that could dramatically affect research in the political science discipline.

This ANPRM requested comments regarding current regulations for protecting human subjects in research, as set forth in 45CFR46, Subpart A (the “Common Rule”). On October 26, 2011, together with Dvora Yanow, I submitted a three page overview as well as responses to over 60 of the 75 questions posed in the ANPRM. Our concern with Institutional Review Board policy is that the review process fails to fit the needs of the needs of field researchers, broadly, and of political scientists more specifically, who often study powerful elites or other experts, topics that raise particular concerns vis a vis ethical practices.
