Teaching

Courses Taught/Developed

Land Use Law, CMP/REDEV 6260*

A comprehensive study of (a) the common law and constitutional bases of modern land use law; (b) the basic mechanics of how land use law is expressed in statutes, administrative regulations, and zoning and subdivision ordinances; and (c) how the various types of land use law manifest themselves in local permitting decisions.

Land, Law & Culture/Planning Law & Administration, CMP 4260*

Uses an ecological systems approach to understanding the history and development of American land use law. The course is built on a policy development model that integrates physical, cultural, and legal influences. It is an upper-division communications and writing (CW) class.

Wasatch Transportation Academy, CMP 6960

A community-based course designed to empower citizen participation in transportation planning processes.

Growth Management Law, CMP 4330/6330 & REDEV 6330

An advanced course surveying U.S. growth management systems currently in operation at local, regional, and state levels. The course covers the mechanics and effectiveness of each system, as well as the purposes and politics behind those systems.

Pedagogy in Planning, CMP 7302

Explores the four basic questions/dimensions of pedagogy—the "how" (technique), the "what" (content), the "why" (motivation), and the "who" (person) of excellent teaching—in the context of urban planning.

Professional Project, CMP 6970 & CMP 6971

The primary capstone course for Master of City & Metropolitan Planning students, intended to serve as an integrative experience where students synthesize and apply planning and analytic skills developed during the course of their study toward the MCMP degree.

Introduction to Transportation Planning, CMP 4710/6710

An introduction to transportation planning issues, processes, and policies.

Community Transport, URBPL 5720/6720

Offers a detailed examination of (a) transportation policy in the U.S., with contrasting analyses of policies and systems in Europe, Asia, and South America; (b) major community and environmental influences and effects implicit in American transportation policy; and (c) transportation planning processes, including both theoretical and practical applications.

Transportation Planning Law & Policy, CMP 6721

An eight-week intensive seminar assessing current federal transportation planning law (principally SAFETEA-LU) and evaluating legislative and policy proposals for replacements to SAFETEA-LU (which expires Sept. 2009).

Honors People & Place I & II, CMP 3101/ARCH 2615

A two-semester team-taught course (with a member of the Architecture Faculty) that explores interactions between natural, built, economic, and social environments through the disciplines of architecture and planning. The course uses six-month community development service-learning projects as a primary pedagogic tool. The course was the University Professorship course in 2006 – 07, and was qualified for Social and Behavioral Science, Humanities, Service Learning, and Honors credit.

Honors Think Tank (2004 – 05), HONOR 3600

A year-long team-taught research-based workshop providing interdisciplinary education on the policies, processes, and conditions affecting central city social and built environments. 2004-05 was the inaugural year for the Honors Think Tank (now titled “Honors Praxis Lab”).

Nonprofit Community Organizations, FCS 5450/6450, POL S 5965/6965

A new course covering the theories and practices relevant to successful community based nonprofit organizations.

Introduction to Consumer and Community Policy, FCS 3600

A team-taught course introducing students to the basics of the public policy process and surveying a series of consumer and community policy issues.

Community and Environmental Change, FCS 5730/6730, URBPL 5962, POL S 5965/6965

An advanced course evaluating community development policy in America, beginning with an assessment of the roles of institutions in communities, continuing with an analysis of community wide development policies, and concluding with an investigation of the role of urban design in promoting community sustainability.
